Sika® ViscoCrete®-20 ET is a liquid admixture for concrete and mortar which is used as high range water reducer/ superplasticizer and retarding admixture. Sika® ViscoCrete®-20 ET is designed to work on a combination of electrostatic adsorption and steric repulsion effects allowing solid particles to be effectively dispersed. Therefore, a high level of fluidity and plasticizing can be reached with a high-water reduction which provides many advantages.

TECHNICAL INFORMATION	
Concreting guidance	The standard rules of good concreting practice, concerning production and placing are to be followed. Recommended dosage	 For medium workability: 0.2 - 0.8% by weight of cement For concrete of high workability, very low water/cement ratio and for self-compacting concrete: 1.0 - 2.0% by weight of cement
Dispensing	Sika® ViscoCrete®-20 ET is added to the gauging water or added with it into the concrete mixer. To achieve the optimum performance, a wet mixing time of at least 60 seconds is recommended. To avoid excess water in the concrete, the final dosage must begin after 2/3 of the wet mixing time.
Compatibility	Sika® ViscoCrete®-20 ET may be combined with many other Sika products. Trials must always be carried out before combining products in specific mixes. Contact Sika Technical Department for additional information and any specific combinations.

Sika $^{\circ}$ ViscoCrete $^{\circ}$ -20 ET must not be added to the dry cement.

- Excessive water addition or overdosing may cause bleeding or segregation.
- When using Sika ViscoCrete -20 ET a suitable mix design has to be produced and the local material sources must always be trialled.
- If frozen and/or separation of the product has occurred, Sika® ViscoCrete®-20 ET may be used after thawing slowly at room temperature and intensive mixing. Before application, suitability tests must be performed.
